Sub:- Allowing Driage on Paddy for Raw Rice Delivered.

Ref:- 1. Your letter No.192 dt.8.1.2014.

Sir,

With reference to the subject & letters cited above, I am to say that detailed instruction on "driage" on paddy in case of Raw Rice delivery was communicated vide this office letter No.21358 dt.21.11.12. In the Release Order prescribed in the Operational Guideline for KMS 2012-13, there is provision for allowing driage in case of Raw Rice.

- 2. The Authorized officers of your district while issuing release order for delivery of paddy for milling from joint custody should have ascertained and indicated the driage quantity on the release order. This was not followed in spite of clear guidelines. There is also lack of supervision from CSO-cum-D.M. on implementation & compliance of procurement guideline.
- 3. Govt. of India has provided driage on paddy @ 1% in case of Raw Rice. In the earlier KMS driage @ 1% of cost of paddy at MSP was allowed to the millers against 100% delivery of CMR due from them. In the KMS 2012-13, actual driage as it occurs during storage of paddy till it is milled was allowed to the millers subject to limit of 1%.
  - 4. In view of above following clarification are issued.
- i) In case the custom miller has not milled entire paddy, the authorized officer must ascertained actual driage of paddy suffered by the mill and report to CSO-cum-D.M. . Actual driage or 1% whichever is less shall be allowed on paddy.

The CMR due from the miller shall be calculated after allowing the draige quantity allowed.

ii) Where the miller has already milled entire paddy and delivered CMR to OSCSC, cost of driage @ 1% of MSP of paddy i.e. Rs.12.50 p.q. or Rs.18.65 p.q. of CMR delivered shall be paid to the miller in lieu of driage.

Action taken in the matter should be reported to OSCSC Head Office.
