With reference to the cited subject, it is to inform you that the quality of Mgunnies in which rice are being delivered to FCI by OSCSC Ltd. not up to the mark. As per instruction in vogue the standard tare weight of a gunny is 665gm. However, it has been observed during inspection that the tare weight of gunnies are of below 615 gm As a result quality cuts i.e. Rs. 1.00 to Rs. 2.00 per gunny are imposed. The quality of gunnies needs to be improved in respect of both texture and structure.

In view of above, you are requested to arrange to deliver rice in gunnies having good texture and structure as per the prescribed specification for smooth delivery of rice and effective storage/transportation of food grains.

The polish of the grains may also be improved to enhance the merchantability as well as to reduce the damaged grains.

- 3. That the labours of FSD/FCI Keonjhar demanding very high rate for unloading of CMR which is a very high rate compare to all other FCI of odisha.

This is not possible at our part to being deliver the CMR to FSD/FCI Keonjhar unless the above facts are to be solved. So it may be solved by arranging a joint meeting of millers and FCI personnel that CMR delivery can be operate smoothly.

In continuance to my earlier letter on the issue dated 21.01.2014, no action in this regard is taken yet. I am herewith sending the sample of gunny bag with this letter to M.D, OSCSC Ltd, and I hope that suitable action will be taken once he sees the kind of gunny bags are supplied to the millers. FCI, Cuttack has categorically told that they will return the Rice lot if such quality of gunny bags are used for packing & delivery to them. They are also deducting the quality cut on account of gunny & also giving us the net weight after deducting 665 grams irrespective of the actual weight of gunny. Hence we are losing Approx. 300 grams per quintal, which amounts for Rs 7.00/- per quintal, with no fault of ours.

So kindly look into the matter & issue necessary instructions or else we will be bound to refuse the receipt of inferior quality gunny further.

Your early and kind attention to this matter will be highly appreciated.

Sir,

We have received 50 bales (15000 pcs) gunny bags from truck no. AP 16 TW 7356 on 20.01.14 loaded from SRI LAXMI SRINIVASA JUTE MILLS LTD, VIZIANAGRAM. We have checked the weight of the gunny through weighbridge and also 10 bags individually. We were shocked to see that both the weighbridge weight & individual weight comes between 500-590 gms per gunny, which doesn't confront the parameters of gunny bags to be used to pack CMR.

Moreover there will be a straight loss of 300gms in packing 1 Qntl CMR as the depot incharge are deducting 665 gms per bag on account of gunny weight from the CMR delivered to them. The loss on account of gunny weight comes at Approx, Rs 7.00 per Quintal.

The weighment slip & sample weight of 10 nos. gunny bags is enclosed for your reference. So kindly look into the matter & issue us necessary instructions.

Your early and kind attention to this matter will be highly appreciated.
