ii) Guideline for procurement of paddy for the KMS 2013-14.

Sir,

With reference to the subject and letters cited above, I am to say that guidelines for payment of Custody & Maintenance Charges was communicated vide letter No.8156 dt.06.05.2014 as per decision taken 164th Board of Directors meeting held on 29.3.14. Board of Directors in their 165th meeting held on dt.28.06.2014 and 166th meeting held on dt.25.09.2014 reviewed the decisions taken in 164th meeting and decided for payment of Custody & Maintenance Charges for KMS 2013-14 in the following manner.

- (i). Custody & Maintenance Charges for 4 months shall be paid to the millers where average storage period of paddy is 4 months or above.
- (ii). Where average storage period of paddy is less than 4 months, Custody & maintenance Charges shall be paid for the actual months of storage subject to minimum of 2 months.
- (iii). For storage period of 6 days or less, storage period shall be ignored and no custody and maintenance charges shall be paid. For storage period of 7 days to 14 days, custody and maintenance charges shall be paid for 15 days. For storage period for 15 days and above and less than a month, custody & maintenance charges shall be paid for one month at the approved rates.
- (iv). The average storage period shall be calculated with the following formula from the figures in the weekly Verification Report.

Total of Average Stock (opening + closing /2)

Total paddy received by the miller for the KMS

The following modalities for payment of Custody & Maintenance Charges has been approved by Board of Directors in 166th meeting held on dot.25.09.2014.

The rate of Custody & Maintenance Charges per month is Rs.2.40 per quintal of paddy as per economic costing of Govt. of India.

- (v) The custom millers shall be paid custody & maintenance charges for KMS 2013-14 only after delivery of 100 % CMR and due compliance of terms of procurement guideline issued vide letter No. 20499 dt.05.11.2013.
- (vi) This guidelines supercedes the instructions earlier issued vide letter No.8156 dt.06.05.2014.
