Points for discussions with Commissioner-cum-Secretary, FS & CW Dept. during weekly review meeting at Bhubaneswar.

- 1. In view of shortage of space and long pendency of DC for RRCs, temporary suspension of inflow of CMR from other districts to Puri district to enable local millers to be allowed to participate and complete Rabi Procurement at an early date as was being discussed yesterday with Hon'ble Minister, FS&CW Dept during review meeting with Collector, Puri.
- 2. Immediate release of pending payment of Rs.2,58,676/- to Sonthalia Rice Mill, Khurda District towards cost of New Gunny bags supplied to Oscsc during KMS 2011-12. The gunny bags were supplied by the custom miller only because of failure on the part of Oscsc in timely supply of Gunny bags. And yet the miller has to suffer for more than 3 years to get reimbursement of cost. This may be an example as to the speed at which things are moving now a day with Oscsc and especially with Accounts Department.
- 3. Arbitrary deduction by district accounts officials is going unabated for lack of any response from Head Office. They have now become "Google Savvy" ignoring Collector approved documents without any basis. We are under immense pain and agony and request for a one to one meeting with accounts head at Corporation Head Office to sort out pending matters.
- 4. Consideration of representation Dt.3.6.2014 (copy enclosed) of Koraput District Millers Assn in allowing participation to 16 millers in Rabi Procurement of 2013-14 who had completed 100% delivery in the month of December,2013 i.e. the very next month of the cut-off month of Nov,2013 with huge 95% cut-off mark. Hardly any other district might be having a cut-off percentage of 75 or 80%. Participation of more millers will ensure evenly utilization of more milling capacity for early liquidation of paddy.
- 5. Considering representation Dt.9.6.2014 of Kalahandi Rice Millers (copy enclosed) in the matter of *movement of rice and allowing more time for sending SMS from existing 7 days to 15 days* since millers are not able to get the requisite Rice Delivery Acceptance Notes within 7 days from RRC/FCI.
- 6. In view of inflow of wheat at FSD, Khurda and SWC, Jatni, *Millers of Khurda and Nayagarh are facing space problem for delivery of CMR to FCI*. Sufficient outward movement programme needs to be planned.

- 7. Framing of suitable policy to overcome the growing menace of defaulting millers through stringent measures.
- 8. Most of the points raised during previous review meeting on 27th May, 2014 are yet to be resolved.
