Sub:- Delivery of CMR to FCI for KMS: 2013-14.

Sir,

With reference to the subject cited above, I am to say that OSCSC has been procuring surplus CMR under DCP Scheme in comparison to the annual requirement under Public Distribution System and other welfare schemes. The surplus CMR is required to be delivered to FCI like previous years in order to utilize the storage space of FSDs available in all districts, evacuate the surplus CMR from the state and to receive the CMR due from the millers in the limited godown space available with OSCSC.

- 2. In this connection the districts having surplus and deficit procurement have been identified basing on their annual requirement under PDS and OWS and procurement of rice in KMS: 2012-13. A statement indicating the name of districts having surplus and deficit procurement of CMR is enclosed herewith for reference.
- 3. 33.93 LMT CMR has been procured in KMS: 2012-13 out of which 8.86 LMT delivered to FCI as on 16.12.2013. About 21 LMT will be utilized under PDS and OWS leaving a balance of about 4 LMT CMR to be carried over to KMS: 2013-14 and retained at RRCs/RRC-cum-DSCs in different districts.

4. Keeping in view of the above, it has been planned to deliver CMR by 29 districts except Kandhamal for effective utilization of FCI depots and evacuation of surplus CMR procured by OSCSC. The criteria fixed for delivery of CMR to FCI by 29 districts for KMS: 2013-14 is as follows. The total delivery of CMR to FCI in KMS: 2013-14 would be 9.71 LMT as per the said criteria and assuming procurement at par with KMS: 2012-13.
