With reference to the subject cited above, I am directed to say that the Asst. Regional Director (S&R), Quality Control Cell, Government of India in Department of Food & Public Distribution has inspected following 07 paddy purchase centres during December'2012 and observed the irregularities and deficiencies in infrastructural facilities provided by RMC as mentioned against each.

1	RMC Yard, Ghess	(i) Weigh Bridge is not functioning. (ii) No cleaning facilities were there. (iii) Paddy has not been heaped.
2	PACS, Garbhana	(i) Paddy has not been heaped. (ii) No cleaning facility was available.
3	RMC Yard, Sohella	(i) Two Grain cleaning machine are available in the RMC yard out of which one is in unserviceable condition and another is in repairable condition. (ii) Analysis Kit was not available. (iii) Paddy has not been heaped.
4	RMC Yard, Padampur	(i) Paddy has not been heaped. (ii) No cleaning facility was available.
5	RMC Yard, Gudeisira	(i) Paddy has not been heaped.
6	RMC Yard, Bargarh	(i) Grain cleaning machine is available but not functioning. (ii) Paddy has not been heaped.
7	RMC Yard, Tora	(i) Grain cleaning machine is available but not functioning. (ii) Paddy has not been heaped.

Department and to Ministry of Consumer Affairs, Food & Public Distribution in Department of Food & Public Distribution, Govt. of India, Krishi Bhavan, New Delhi is enclosed for ready reference.

It is therefore requested to take all corrective measures and submit compliance for onward submission to Government of India within 07 (seven) days from receipt of the letter.
