**Sub:- Delivery of CMR at FCI Depots in KMS: 2012-13.**

Sir,

With reference to the subject and letter cited above, I am to say that as per decision taken in the meeting held in FS & CW Department, Odisha and communicated vide letter No. 19752 dt.17/12/2012, the following arrangement has been made for delivery of CMR to FCI in KMS: 2012-13, in order to ensure maximum utilisation of capacity of FCI depots.

2. **20% of the CMR due from the custom millers of your district shall be delivered at FCI depots. Balance 80% of CMR due shall be delivered at RRCs.**
3. Accordingly for the CMR available for delivery with the custom millers, Delivery Certificate shall be issued in such a manner that 20% CMR is delivered to FCI within the current KMS.
4. The instructions communicated vide Corporation Head Office letter No. 21655 dt.26.11.2012 regarding delivery of CMR at FCI depots shall be strictly adhered to while issuing Delivery Certificates to the custom millers.
5. The custom millers shall be impressed upon about this arrangement made for efficient utilisation of FCI depots for early recovery of CMR.
6. A daily report shall be collected by OSCSC Head Office on delivery of CMR to FCI. Accordingly an officer must be nominated who will pass information regarding this.
7. **To coordinate with FCI on daily basis an ACSO must be kept in charge for smooth delivery.**
