Sub: - Receipt of CMR of KMS: 2013-14 from millers - Utilization of space at RRC.

Ref: - i) Letter No. 21503 dt.20.12.2013.

ii) Letter No. 21968 dt.28.12.2013.

Madam / Sir,

Inviting reference to the subject and letters cited above, I am to say that it was decided not to receive CMR for the KMS: 2013-14 in boiled rice procuring districts at RRCs till March, 2014 so that the surplus CMR of KMS: 2012-13 can be utilized.

- 2) In the mean time delivery of CMR for KMS: 2012-13 to FCI has been ceased w.e.f 31.12.2013 and some districts have started delivery/ are likely to deliver CMR for KMS: 2013-14 to FCI from January, 2014.
- 3) It has come to the notice that some millers of boiled procuring districts have completed 100% delivery of CMR for KMS: 2012-13. Those millers are to be given opportunity to deliver CMR in RRCs along with delivery to FCI depots so as to encourage them .
- 4) In view of the above, it is decided that the millers who have completed 100% delivery of CMR for KMS: 2012-13, shall be allowed to deliver CMR for KMS: 2013-14 in the ratio of 25:75 at RRC and FCI from January, 2014 to March, 2014.
- 5) In some districts, there is no vacant space in the FCI depots to receive CMR for KMS: 2013-14. In those cases CMR may be received in RRCs for the time being till vacant space in FCI depots is made available. On availability of space at FCI depots, the millers are to deliver CMR to FCI as per earlier instructions and above decision at item (4).

Those who complete delivery of 100% of CMR for 2012-13 KMS may be allowed to deliver CMR to RRC as per instruction at item (4) from the date of their complete delivery.
