Dear Mr. Padhi,

The Food Corporation of India have reported that huge quantity of CMR is still pending for delivery to FCI in Central Pool by the Government of Odisha. The FCI have also informed this Department that only 64,835 MT of rice was delivered to FCI during October, 2014 and 1,23,505 MT of CMR was delivered to FCI during November, 2014 till 27.11.2014. On the request of Government of Odisha, extension of time for delivery of CMR/levy rice into the Central Pool for KMS 2013-14 was allowed upto 31.12.2014.

2. I would like to request you to take necessary steps for ensuring completion of delivery of CMR/levy rice of KMS 2013-14 by 31.12.2014, as no extension of time would be allowed beyond 31.12.2014.
