**Sub: Custom Milling of FCI paddy during 2011-12 KMS.**

Enclosed please find letter dated 29.12.2011 of Balasore District Rice Millers Association sent to Area Manager, FCI, Balasore with a copy to our Association in the above matter.

You are quite aware that at the request of our State Government, GOI had been pleased to delink TC from Milling Charges by reducing Rs.5/- per quintal. Transport charges on both Paddy and Rice are now payable from '0' KM. Accordingly, Odisha State Civil Supplies Corporation Ltd is paying milling charges at the revised rate and also transport charges for both paddy and rice from '0' KM.

A target of only 50,000 MT Rice has been assigned to you for 2011-12 KMS which hardly match to your stature. This target can be easily achieved if the terms of operations are made in uniformity with other procurement agencies. Millers from other districts like Kalahandi, Bargarh and Bolangir etc have also requested our Association to take up the matter with you in line with the suggestions made by Balasore District Millers.

We therefore, request you to consider our proposal for payment of milling and transport charges as per economic cost sheet of GOI and as is followed by Odisha State Civil Supplies Corporation.
