Sub: Revision of incidentals on CMR operations for KMS 2012-13.

Most respectfully, we draw your kind attention to our earlier submissions made from time to time on the above subject. More than 6 months of current KMS 2012-13 have already passed and it is high time that the rates of various incidentals are revised and communicated for settlement of bills. We suggest as follows for your kind consideration:-

- a) *Mandi handling charges:* Rs.5/- per quintal or at least 50% for loading of paddy at paddy purchase centers out of total Mandi handling charges allowed for entire Mandi operation including loading charges.
- b) *TC on Paddy and Rice*: Minimum TC be revised to Rs.12/50 per qtl for 1st 10 KM and @ Re.0.65 paise per quintal for distance beyond 10 KM for both Paddy and Rice (Kindly refer to the discussions held during procurement review meeting on 29.01.2013). *Possibility of appointing Handling & Transport contractor for delivery of paddy and lifting rice from mill may also be explored during the ensuing Rabi Procurement season.*
- c) *Rice handling charges* be revised to Rs.5/- per qtl for delivery at RRC/CWC/Oswc and to Rs.8/- for delivery to FCI in view of unprecedented labour charges demanded by the laborers.
- d) *No deduction towards insurance premium* on Custom Milling Paddy & Rice as the stock belongs to the State Procuring Agencies.
- e) Payment for other remaining items like cost of new gunny, gunny depreciation, custody and maintenance etc as per economic cost sheet of GOI under DCP operations for the state of Odisha.

Your honour may kindly appreciate that there has been many fold increase in the cost of all the inputs especially due to *frequent increase in fuel prices*, *electricity rates and revision of minimum wages* by the Government.

We therefore, most humbly request your honour to kindly consider our above submissions sympathetically before finalization of various incidentals payable to custom millers for KMS 2012-13.
