Nomination of NACOF as a Govt. Agency in the process of procurement of paddy during KMS 2014-15.

Sir,

I am directed to invite reference to your letter No.188 dt.09.12.2014 on the subject mentioned above and to say that after careful consideration, Govt. have been pleased to engage NACOF as Agency for procurement of paddy during the KMS 2014-15 as per following conditions.

- 1. NACOF shall implement orders, instructions Guidelines and Policy issued by this Deptt. time to time for procurement of paddy in the State of Odisha.
- NACOF shall pay Minimum Support Price (MSP) to farmers. In case any
  complaint of non-payment of MSP is found in any enquiry conducted by State
  Govt./District Administration, this nomination shall be cancelled and penalty
  will be imposed.
- NACOF shall deliver entire CMR to FCI after Custom Milling of Procured Paddy. They should furnish weekly report of procurement to concerned CSOs and also to Department.
- NACOF shall consult concerned Collector for tagging of mills for Custom Milling of paddy.
- 5. NACOF shall procure paddy directly from the farmers or with the help of PACS, WSHs and Pani Panchayats as per quality specifications laid down by the Govt. of India and in accordance with the Guidelines issued by the FS & CW Department from time to time.

- 6. The Minimum Support Price should be paid by Account Payee Cheque or online transfer wherever such facilities are available.
- 7. District Administration will declare the existing Market Yards located in procurement areas belonging to Regulated Market Committee (RMC) as PPCs.

Target of 5000 MT in terms of rice for Boudh district and 10000 MT in terms of rice for Bolangir district has been allotted for procurement of equivalent of paddy.
