Against the total CMR due of 29.03 lakh MT, FCI has received 7.41 Lakh MT of CMR and OSCSC has received 2157375 MT making a total receipt of 2898072 MT. This leaves a balance of about 9133 MT of rice to be received from the Millers by OSCSC in following districts.

The defaulting Custom Millers are mainly from Kalahandi,Bhadrak & Subarnapur districts against whom action needs to be taken for recovery of the CMR. The Commissioner-cum-Secretary instructed the M.D.,OSCSC Ltd. to make analysis of the defaulting Custom Millers district wise and Miller wise. The M.D.OSCSC Ltd. informed that FIR had been lodged against Millers of Kalahandi & Subarnapur districts. Three Mills of Bhadrak district i.e Bharati Rice Mill, Krishna Rice Mill and S.N.Rice Mill are to deliver 2000 MT, 1100 MT and 270 MT of CMR respectively. The MD informed that there is no rice with a Miller of Deogarh who has been asked to deposit money as per economic cost of CMR KMS 2012-13.

The Commissioner-cum-Secretary insisted for taking specific action against these Miller defaulted in delivery of CMR.

2. Review on Procurement of paddy and delivery of rice for KMS 2012-13

The review of procurement of paddy and delivery of rice by different Agencies for the KMS 2012-13 was made. On review it was found that 4475531 MT of paddy has been procured as on 22.5.2013

The following table shows the Agency wise procurement of paddy and delivery of rice as on 22.05.2013.

It is seen that paddy procured this year (till on date) is 38% more than that of last KMS and the CMR delivery is 39% higher than last KMS. But CMR due to be delivered as on date is more than 17 lakh MT and is likely to rise due to bumper Rabi harvest this year.

Plan for delivery to FCI & Evacuation by FCI.

During review it was found that 490248 MT of CMR has been received by FCI till date in this KMS. The DGM ,FCI informed that utilisation of Storage space is around 88%. Nawarangpur district is delivering slowly to FCI than the

delivering slowly to FCI so that more quantity is delivered in the larger interest of the State.

D.G.M., informed that FCI will evacuate the planned 120,000 MT of CMR in May,2013. Secondly, there would be no induction of wheat to Odisha in May,2013 which is in response to States request to FCI on the matter. For June,13 they will request for evacuation of 1.1 LMT of Boiled Rice & 0.1 lakhMT of Raw rice with no wheat induction.

4. Programme for delivery of rice for May,201

A programme of 1,66,616 MT was made for delivery of rice at FCI depot by different districts on OSCSC,MARKFED, NAFED & TDCC account for the month of May,2013. The Collector and CSO of the districts will deliver rice in respect of FCI depot as per the programme given earlier. The DGM informed that 1.20 Lakh MT will be evacuated in June, 2013 & there will be no induction of wheat.

5. Payment of dues by FCI

M.D., OSCSC informed that dues to the extent of Rs.264 crore for the year 2011-12 and Rs.154 crore for the year 2012-13 is pending with the FCI for payment. Similarly an amount of Rs.23.60 crore & Rs.12.98 crore is pending for payment to MARKFED & TDCC respectively. The D.G.M., FCI was requested to look into the matter and expedite payment of outstanding dues of OSCSC Ltd. and MARKFED expeditiously.

6. Issues on Transportation cost paid by FCI.

It was discussed that FCI is giving Rs.0.27 paise per Km per quintal towards transportation charges beyond 8 Kms. and there is no revision since 2011. As per guideline in the economic costing, transportation charges is to be paid either at the approved by Collector of the District or the FCI rate which ever is lower. Now, the State Govt. has fixed the transpiration rate @ of Rs.7/- per quintal for first 10Kms and at the rate of Rs.0.35 per quintal per Km. for subsequent distance. The rate i.e. Rs.0.27 per quintal per km. fixed by FCI is not based on market rate. Hence it was decided that FCI will be requested to reconsider the transportation rate and reimburse the transpiration charges for paddy and rice as per the rate decided by the State Govt. for the KMS 2012-13.

- b) Request for an opportunity to put forth their suggestions before the Sub Committee constituted to propose amendments to "Odisha Rice and Paddy Procurement (Levy) and Restriction on Sale and Movement Order, 1982.
- c) Rotation of stocks available with CWC/SWC on "FIFO" basis. RRCS with limited storage capacity are having more turnover compared to higher capacity godowns with CWC/SWC.
