Sir,

With reference to Government of India letter and subject cited above, I am to send herewith format of request for extension of milling of paddy and delivery of CMR/ Levy rice to Central Pool. Paddy procurement and rice delivery is being reviewed at the State Level regularly in Weekly Paddy Procurement Review meetings. A total of 11.18 lakh MT CMR/ Levy rice are yet to be delivered.

During the Kharif & Rabi season, a total of 52.45 lakh MT paddy equivalent to 35.47 lakh MT CMR/ Levy rice has been procured. About 24.29 lakh MT CMR/ Levy rice has already been delivered to FCI/ OSCSC Ltd. upto 31.7.2015.

In some districts there have been space constraints at the FSDs of FCI because of non-availability of adequate storage capacity. Hence, it was requested vide this Department letter No.11677 dt.19.6.2015 to allow three months of more time for delivery of Kharif CMR/ Levy rice to Central Pool. But Government of India allowed only two months i.e. upto 31.8.2015 for delivery of Kharif CMR/ Levy rice to Central Pool.

You are therefore requested to kindly appreciate the above difficulties and take appropriate steps to extend time limit upto 31st December, 2015 for delivery of entire Kharif & Rabi CMR/ Levy rice to FCI. Besides, FCI may also be requested to expedite evacuation of surplus rice @1.5 lakh MT per month to outside the State so as to create storage space for receipt of higher quantity of CMR every month.

- 5. If the reason for delayed milling is lack of sufficient milling capacity in the State, then following details should be filled in;
 - (i) Total Milling Capacity available (per day) in the State.
 - (ii) Average quantity of paddy milled per day in the season in the State.
 - (iii) Details of tangible efforts made by the State Govt. to improve milling capacity of paddy in the State.
 - (iv) Quantity of paddy proposed to be milled per day, if extension is granted.
- 6. In case the reasons for delay in delivery are other than storage capacity and lack of milling capacity, such as quality issues, lack of sufficient staff etc. then the details should be provided hereunder:
 - 1. Procurement is starting from mid-November in Western Odisha and from mid-December to early January'2015 in Coastal Odisha. This is causing delay.
 - 2. Due to backlog of CMR of last KMS kept few of the miller engaged till December-January.
 - 3. Lack of adequate storage space is resulting in late receipt of CMR from the Millers.
 - 4. Limitation in receipt by FCI and evacuation of surplus CMR due to very few rake points in surplus western districts.
 - 5. The procurement during the KMS 2014-15 was 35.47 lakh MT in terms of rice. Whereas the annual PDS allotment is about 19 lakh MT for Odisha. Slow receipt and evacuation of surplus CMR has resulted in delay in receipt of CMR.
